## ORDINANCE NUMBER 5.

AN ORDINANCE ESTABLISHING RULES AND REGULATIONS FOR THE USE AND SERVICE OF THE WATERWORKS SYSTEM OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS.

WHEREAS, the Board of Trustees of the Lakeside Water District has adopted Ordinance Number 1, providing for the construction of a waterworks system to be owned by said District and authorizing the issuance of waterworks revenue bonds of the said District to provide funds for that purpose, and

WHEREAS, it is necessary that the Lakeside Water District establish rules and regulations for the use and service of said waterworks system.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS, AS FOLLOWS:

- SECTION 1. Water shall be deemed to have been supplied to any property connected to the waterworks system during any month, unless the water user shall prior to the first day of the month have given written notice to the treasurer that service should be disconnected on or prior to the first day of such month. Upon the receipt of such notice, water service shall be discontinued in accordance wherewith and shall not be resumed until a request for resumption of water service shall be made. In the event that water service shall be discontinued for any reason a charge of \$5.00 shall be paid by the user at the time of application for reconnection.
- SECTION 2. The Board of Trustees reserves the right to make a special assessmens not covered by the regular rate ordinance, or which, in the judgment of said Board, should be charged to comply with Ordinance Number 1.
- SECTION 3. The Board of Trustees reserves the right to make special charges for water supplied to properties not specificially covered by the regular rate ordinance, or which, in the judgment of said Board, should be charged special rates.
- SECTION 4. Water service shall be furnished only upon the filing of an application therefor with the Chairman or Treasurer upon a form to be supplied by him. The application shall state the name of the applicant, the premises to be served and state the use for which the water is to be supplied. If the applicant is the owner in fee simple of the premises, then a deposit of Five Dollars (\$5.00) shall be required. If the applicant is not the owner in fee simple of the premises, then a deposit of Twenty Dollars (\$20.00) shall be required. Such deposit may be applied to any delinquent or final bill on discontinuance of service. Upon the disconnection of the water service any balance of such deposit shall be returned to the applicant without interest.
- SECTION 5. All connections and water applied for hereunder, and all water used hereunder, shall be upon the express conditions that the Lakeside Water District shall not be liable nor shall any claim be made against it for damages or injury caused by reason of the breaking of any main, branches, service pipes, apparatus, or appurtenances connected with said system or plant, or any part or portion of said plant, or by reason of stoppage, alterations, extensions or renewals.
- SECTION 6. The District and its employees shall have ready access at all reasonable times to the premises, places or buildings where water is supplied for the purpose of examining and testing the consumption, use and flow of water, and it shall be unlawful for any person or corporation to interfere with, prevent, or obstruct said District or its fully authorized agent, in its conditions prescribed in this section.
- SECTION 7. No water consumer may supply water to other families or allow them to take it, except for use on the premises and for the purposes specified in the application.
- SECTION 8. The District reserves the right to shut off water at any time in the mains for the purpose of repairing, cleaning, making connections with or extensions to same, or

for the concentration of water in any part of the District in case of fire, and for restricting the use of water in case of deficiency, in supply, including the suspension of the use of water for sprinkling lawns or gardens. No claim shall be made against the District by reason of the breaking of any service pipe or service cock, or damage arising from shutting off of water for repairing, laying or relaying mains, hydrants or other connections or repairing any part of the water system, or from failure of the water supply, or by increasing the water pressure at any time, or from concentrated or restricted use of water as above.

SECTION 9. No owner or plumber shall be permitted to conduct water pipes into any two distinct premises or tenaments, unless separate and distinct stopcocks and meters shall be placed on the outside of each such premise along the road right-of-way opposite the same, nor shall any pipe be allowed to cross lots of buildings to adjoining premises. Duplex flats, double houses, and apartment houses shall be considered as one "premise" and shall be construed to cover all buildings and divisions under one common roof, owned by one party who will be charged for all service to such premise.

SECTION 10. No water connection shall be made or water and sanitary fixtures installed on the premises unless they shall meet the standards of quality and installation as approved and required by the Department of Public Health and the County Sanitary Engineer.

SECTION 11. All Ordinances or parts of Ordinances in conflict herewith are hereby expressly repealed.
