ordinance no. 7

AN ORDINANCE FOR THE ANNEXATION OF TERRITORY TO THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS.

WHEREAS, the requisite number of legal voters residing in certain territory contiguous to the Lakeside Water District, Jackson and Williamson Counties, Illinois, and more particularly hereinafter described, having filed a petition in the Circuit Court of Jackson County, Illinois, on the 12th day of June, 1967, praying for the annexation of the said described territory to the Lakeside Water District, Jackson and Williamson Counties, Illinois, and

WHEREAS, a hearing was had on said petition on the 12th day of July, 1967, giving all interested persons an opportunity to be heard touching upon the sufficiency of the petition and upon the boundaries of the territory sought to be annexed, and for the purpose of hearing objections to the aforesaid petition, and cords and files of said Board.

WHEREAS, a Notice of said hearing was published in the Southern Illinoisan, a daily secular newspaper having a general circulation within the said Lakeside Water District and within the territory sought to be annexed thereto, said Notice having been published on the 16th day of June, 1967, being at least fifteen days prior to the date set for hearing, as provided by law, and saids Water District.

WHEREAS, no objections were made to said petition at said hearing, and

WHEREAS, the Court having examined said petition and finding that the same was sufficient and conformed with statutes in such case made and provided, and

WHEREAS, the Court ordered the question of annexation of said territory to the Lakeside Water District, Jackson and Williamson Counties, Illinois, be submitted to the Board of Trustees of the Lakeside Water District, as provided by law, and

WHEREAS, a certified copy of said order was filed with the Chairman of the Board of Trustees of the Lakeside Water District, Jackson and Williamson Counties, Illinois.

THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS, that the following described territory, to-wit:

Section 6, Township 9 South, Range 1 East of the 3rd Principal Meridian, Williamson County, Illinois

be and the same is hereby annexed and made a part of the Lakeside Water District, Jackson and Williamson Counties, Illinois, for all purposes.

This Ordinance shall be in full force and effect from and after its passage, approval and recording in accordance with law.
