ORDINANCE NO. 76

AN ORDINANCE TO AMEND ORDINANCE NO. 74 BEING AN ORDINANCE ESTABLISHING RULES, REGULATIONS AND RATES AND CHARGES FOR THE USE AND SERVICE OF THE WATERWORKS SYSTEM OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKESIDE WATER DISTRICT, JACKSON AND WILLIAMSON COUNTIES, ILLINOIS, AS FOLLOWS:

Section 1: That Section 1 of Ordinance No. 74 be amended to read as follows:

That there shall be and there are hereby established rates and charges for the use of and for the water supplied by the waterworks system of the Lakeside Water District, Jackson and Williamson Counties, Illinois, as follows:

Service Charge:

There will be 3 rates for all customers:

Rate 1: a rate for a standard 5/8-inch meter;

Rate 2: a rate for a single-family residence with a 1-inch meter;

Rate 3: a rate for all other customers with a 1-inch meter or larger.

The basic service charge for Rate 1 shall be \$12.00 per month. The basic service charge for Rate 2 shall be \$32.10 per month. The basic service charge for Rate 3 customers shall be \$60.00 per month.

Water Charge: In addition to the service charge, all customers shall pay for water usage, as shown by the water meters, the following charges: 1) Rate 1 customers shall be charged at the rate of \$6.38 per thousand gallons. 2) Rate 2 and 3 customers shall pay a surcharge of 10% on their water usage.

Minimum Charge: The minimum monthly bill for Rate 1 customers, including the basic service charge and the water charge, shall be \$31.14. The minimum charge includes 2,000 gallons of water.

The minimum monthly bill for Rate 2 customers, including the basic service charge and water charge, shall be \$46.14. The minimum charge includes 2,000 gallons of water.

The minimum monthly bill for Rate 3 customers, including the basic service charge, the water charge, and the 10% surcharge, shall be \$67.02. The minimum charge includes 1,000 gallons of water.

Section 2: That except as hereby modified and changed, Ordinance No. 74 shall remain the same and in full force and effect.

Section 3: That within 30 days after its adoption, this Ordinance shall be published in the Carbondale Times, a newspaper published in Jackson County, Illinois and of general circulation within the District, and shall become effective with the July billing.

Section 4: The District will pay for a meter reducer from 1-inch meter to 5/8-inch meter for one year from June 8, 2021 at the request of any District customer. On or after June 7, 2022, the District customer will be responsible for payment of a reducer.
